Terms & Conditions

1. By returning this signed Sponsorship Agreement ("Agreement"), you agree to be a non-exclusive Sponsor or Exhibitor of The Indigenous Cancer Survival Forum 2010 organized by m247consulting and held at Cancer Council NSW, 153 Dowling Street, Woolloomooloo on 19 May 2011 on the following terms and conditions set out below and as attachment to this Agreement.
2. Upon receipt of your signed agreement together with a cheque for the deposit, acknowledgement of receipt will be sent in writing with a Tax Invoice.
3. You agree to pay m247consulting the full amount payable; and
4. Sponsorship entitlements will not commence until 50% deposit has been paid in full.
5. Monies paid are non-refundable.
6. Please note that your requested category of sponsorship may have a limit to the number of sponsors as specified in the attached documentation and preference will be determined in order of receipt of the signed Agreement and deposit cheque. The Forum Organisers will notify you if you are unable to participate in your requested category.

8.
